Rank 1: Most interest. Dependency on Viewer. Only if used AT + ENQ

Rank 2-3: High result with some very low answers

Rank 4: May be universal import control to request the document from any repository in a defined form. API exists already today and might need some awareness about enquiry import process

Rank 5-8: Very close results with big variance between organizations that are aware about Enquiry and others

Rank 9-10: Low results. Mostly interesting for organizations that do not plan to use AT

Organization support	- Teams or organization support. Comments can be seen between team members.
Redlines	<ul> <li>Source file required to compare to. Must be an option to load previous version together with the new version in enquiry or offer user to buy previous version (integration with store?)</li> <li>Viewing previous versions</li> <li>Can it be used to compare PDFs?</li> <li>Limited enquiry + redlines must work together</li> </ul>

- At has functionality that allows you to upload valid NISO STS files into AT.
- Note: AT is based on the same software ISO/IEC/CEN/CENELEC are using for their OSD project
- But what IS valid NISO STS??
- in Theory, XML provided by ISO/IEC/CEN/CENELEC should follow the Guidelines for coding NISO STS Standards
  - The ISO OSD should produce XML as defined in the guidelines
- in Practice:
  - there are still differences between ISO and IEC in terms of encoding
  - the current ISO OSD is not in line with the guidelines (work in progress)
  - the coding guidelines have evolved over the years, but no organization have updated the XML in their back-catalogue
  - The QC done on the XML especially at CEN/CENELEC and IEC is quite poor and we often encounter XML that is invalid/ missing images/...
- but: AT requires one very specific way of XML encoding in order to work correctly
- RESULT: not all files received from ISO/IEC/CEN/CENELEC will import into AT!



.... so what can we do about it?

#### **Standards Digital**

- Implement transformations for the most common use cases preventing upload, such as:
  - graphic files stored in different locations
  - <reg-meta> instead of <std-meta>
  - footnotes at the end of the standard,
- Influence ISO's development team to be more accurate in their XML encoding


Make yourself heard!

- → provide feedback to ISO/IEC/CEN/CENELEC when you find errors and request correction
- → make them understand that the coding guidelines and their correct application are important and you want to be involved!
- → share import issues with SD so we can add potential transformations

### 1. Summary of discussion in the group

- Generally, the group agrees the quality of the provided XML is poor, especially from CEN/CENELEC
- SFS has escalated this problem since 2015 without much success
- SN has also escalated this problem for multiple years and is now:
  - Correcting the poor quality XML using SD Authoring
  - Creating tickets at CCMC detailing which errors appear in which file and asking for corrections
  - New IT Director Groven Serge <u>SGroven@cencenelec.eu</u> is aware and a good contact point also for others to escalate the issue to
- It is foreseen that when CCMC, ISO and IEC publish their XML directly from OSD, the quality issues will disappear; however, it will be years until all standards are published from OSD, therefore it is still worth and relevant to escalate issues found to these organisations
- Members need to get more involved and have more visibility about the ISO/IEC coding guidelines for NISO STS
- CEN TF Digital content has an XML sub-group which should be reactivated

### 2a. Authoring National Adoptions: principles



Adoptions are like an Onion: the national content is added around the European and/or International content

#### Basic assumptions:

- the European and International content is not modified
- National content can be added to the front of the document:
  - national foreword
  - national coverpages
- National content can be added to the back of the document:
  - national Annexes
  - national Bibliography
- National content can be added to the European and International content through
  - National notes
  - National footnotes





#### Option 1: All in one

- The international and European content is added into a single document in AT
- National content is added, i.e.
  - National foreword
  - National notes/footnotes
  - National Annexes
- Single XML file is produces from AT which can then be used for publishing

#### Option 2: Piece by Piece

- If we assume we don't want to touch the European/international content at all, we don't need it
  in AT
  - in case of national notes, these can be added into the national foreword
- In AT, we create a national annex (specific template only containing the <back> matter of the standard)
- in AT (or elsewhere), create the national foreword
- Use your XML production chain to assemble the XML into a single file using the original ISO/CEN xml files and the nationally created files that can then be used for publishing



### 2a. How do you create national adoptions?



- ✓SN have fully automated their adoptions process using Option 2
  - ✓ National Annexes are created as separate documents
  - ✓ National Foreword created in their project management db
  - √ Réalta assembles the different pieces of XML according to predefined rules and returns a consolidated XML and PDF



- AT is not a translation software
- Each working document has a single language assigned to it
- Therefore you either:
  - upload a translated XML (from a translation software like Trados)
  - upload the XML in the original language and overwrite it with the translation bit by bit
  - create a new document from scratch and write your translation in there





# 2b. How do you work when you need to translate documents into your national language?



- ✓ SN:
  - ✓ Use SDL Trados for translation based on XML from ISO/CEN
  - ✓ export XML of translated document
  - ✓ upload translated documents into SD Authoring to do editing
  - ✓ Currently there are more efforts done on translations of chapter 3 Terminology to build up terminology database
- ✓ NEN:
  - ✓ Translations done in MS Word, outsourced to translation agency, then committee review and proof reading
  - ✓ no XML used at this point
- ✓ AFNOR:
  - ✓ using SDL Trados based on MS Word
  - will start experimenting with XML file and then use AT for editing, review etc similarly to SN
- ✓ SFS:
  - ✓ using SDL Trados based on MS Word, then use eXtyles to create the correct XML export for original and translated standard
  - Main issue: how to match up sections between the translated and original XMLs. Currently based on semantic IDs, but with SD Authoring & OSD, GUIDS are not useable for matching
  - ✓ there may need to add some more attributes or other identifiers for sections to enable this matching
- ✓ UNE:
  - ✓ SDL trados based on MS Word and then produce PDF, XML is currently not required but will start to become more importing with the SMART initiatives



### 3. Working with Commenting





Commenting is a feature of the system that enables comments and proposals.

#### **Comments:**

Make a comment in the text without adding a concrete proposed change

#### **Proposals:**

- proposes an actual change to the existing text/ equation/ figure/ table
- Shown in a "track-changes" way
- proposed changes can be automatically applied

NOTE: in Fonto 8, comments/proposals are immediately shared when user enters them; in the current production system comments are first private and need to be actively shared



### Some tips and tricks



#### Use tags to categorize your comments

Tags are like keywords that can be associated to comments; they can be used to categorize comments and filter on this categorization, for example, tag a subset of comments:

- 1. for review in an upcoming meeting
- 2. for review by a specific person or to assign responsibility of an area to a specific person
- 3. for noting things that should be handled in the next edition of the document
- 4. etc

#### **Download comments**

For sharing comments with people that do not have access to the AT tool, you can export the comments in 2 formats:

- 1. Excel format: contains all relevant information on the comment in multiple columns
- 2. MS Word format: specifically designed to match the ISO commenting template

We recommend to use the exporting of comments as little as possible; comments cannot be imported back, so it's best to use the comment filtering features in AT to find what you are looking for



### Some tips and tricks



#### Reach consensus

Comments and proposals can be controversial; it may be difficult to reach a consensus within the WG on which comments should be accepted/ rejected.

Did you know that on each comment you can "vote" to support/ don't support the comment? This can be done "live" in a WG meeting or people could do this in preparation of a meeting.

#### **Import**

- Improve process for onboarding new SDO data providers:
  - Custom template in excel format that would need to be filled out by customer or end SDO that Import could import.
  - During process user importing would be prompted to upload files corresponding to the standards.

#### **Store**

- Search
  - SD to provide customers documentation on Store search, including details on how it works, and how it can be optimized based on customer requirements
- SD to create library for different release notes
  - Product team switching to "release based" development with information on what features will go out in the next release
- Custom SSO logins
  - Quite important for enterprise customers.
- SD should offer collections based on criteria other than ICS codes.


